- Cost estimates for equipment and contract work
- Project implementation plan and projected time line
- Page 1 of the most recent filed IRS 990 form
- List of reoccurring annual funding sources (if applicable).

#### Grant funds CANNOT be used for any salaries or fees

\* Grant awards will be announced to the organization by letter. The Foundation requires a follow-up letter confirming the implementation of the project and detailing any applicable measures of success. Grant recipients are required to make their approved purchase and requisition grant funds by March 31st of the year following the year in which the grant is awarded. Failure to requisition the grant monies by the deadline could result in forfeiture of the grant.
